## **Letter from the Council Leader**

Dear Residents,

With Heathrow expansion seemingly one step closer in light of the Government's recent vote, it's now more important than ever that we ensure our communities are properly considered. We have published a list of ten key requirements from Heathrow which we see as crucial to ensuring that our communities get the best possible deal. More details on this can be found on page 7.

There is clearly an urgent need for better public transport to the airport. We don't just want an occasional bus service which may be withdrawn a few years later. We are actively promoting an innovative Southern Light Railway solution which we believe is the best way to achieve seamless journeys to the airport from the south, whilst also benefiting our residents and minimizing environmental harm.

We have recently announced that we are planning to build a brand new, state-of-the-art, facility to replace Spelthorne Leisure Centre. We are consulting on the options and there will be further consultations as the scheme evolves so please ensure you have your say.

Neither are we forgetting the importance of the day job. We think it is really important to ask residents what kind of services they want to see going into the future so we are planning to consult residents on budget choices in the autumn. Again, I would urge you to take part in helping to shape our future.

As I write this, the sun is shining and I hope that continues so you can get out and about to one of our events featured on page 11, or indeed just enjoy what our Borough has to offer with a walk along the river, on Staines Moor, or in one of our many beautiful parks.

## A new Mayor for Spelthorne

Cllr Jean Pinkerton OBE was elected as the new Mayor for Spelthorne at the Annual Council Meeting on Thursday 17 May. Cllr Mary Madams was elected as Deputy Mayor.

Cllr Pinkerton was first elected to the Council to represent Staines South in 2003. Over the last 15 years she has been a member of, and chaired, various committees and held Cabinet positions with responsibility for Communications, Housing, Health and Wellbeing and Independent Living. She was also elected as Deputy Leader in 2012 and 2013.

Staines has been Cllr Pinkerton's home town for 39 years. She has three daughters, five grandsons and a great granddaughter. Prior to her retirement, Cllr Pinkerton had a long and rewarding career in education and worked as a Headteacher for over 17 years. In 2013 she was awarded the OBE for services to education.

During her term as Mayor, Cllr Pinkerton will be supporting the following charities:

- east to west – offering support to children, young people and their families on a range of emotional and practical issues
- Rentstart – assisting single people and childless couples to access accommodation in the private rented sector
- Shopmobility – helping people with mobility problems to get around Staines town centre
- The Penrose Club – providing social activities for adults with special needs

After being sworn in as Mayor, Cllr Pinkerton said: “My theme for the year is that ‘Spelthorne is special’. I want people to be aware of all the very positive aspects of our Borough and the many talents within it.”

I have been elected by my fellow councillors to this prestigious post and I will do my best to carry out the role with integrity and be a good ambassador for our Borough. I hope you will all support me and therefore my charities, in any way that you can.”

## Property to let?

Hosted by the Council and Spelthorne Rentstart, the Borough's second Landlord Forum was held on 8 May at Shepperton Studios.

Landlords were introduced to the Council's Rent Assure Scheme which guarantees to pay landlords the full market rent for their properties for up to two years.

The Council will find the tenants and, when approved by the landlord, draw up the agreements free of charge. A free inventory check is carried out at the beginning and there is the reassurance of a six-week repair bond. Ongoing support for both the landlord and the tenant is available for the duration of the tenancy.

## Pot holes in Surrey

The state of the roads is frustrating many of our residents who contact us by the hundreds by phone, email, social media and even visiting the Council. However, it is Surrey County Council who are responsible for the upkeep of our roads and pavements, not Spelthorne Borough Council.

A petition has been set up to ask the government to debate Surrey's pothole issues in the Houses of Parliament. The online petition asks the government to reform the funding formula which decides how much cash should be given for road repairs. Surrey County Council says the method for calculating the amount penalises the County because it is calculated on the length of a road and not the volume of traffic.

## Surrey County Council Cuts

Earlier this year Surrey County Council announced that they need to make savings of £66m to balance their budget for 2018/19.

Full details of how Surrey's cost saving programme will affect Spelthorne residents are not yet known but it is likely to affect the services provided, or funded, by Surrey. Some of Surrey's saving initiatives, such as changes to fire stations, were announced last year but further significant reductions are on the horizon.

Here are some of the reductions which have recently been announced:

Service	Surrey County Council's proposed reductions/changes	How is Spelthorne responding?
Telecare support for patients being discharged from hospital	In 2017/18 Surrey withdrew Telecare services such as smoke alarms and bed sensors for clients who failed to meet a new threshold meaning an estimated 98% clients will no longer receive free Telecare	Spelthorne stepped in to continue funding part of the service
Support to help vulnerable people stay in their rental property	Surrey has reduced the funding given to Spelthorne Council by £20,000 per year	Spelthorne has funded the deficit to try to prevent vulnerable people becoming homeless
Recycling	Funding given by Surrey to Spelthorne for recycling is being reduced from £387,000 in 2017/18 to £104,000 in 2020/21	Spelthorne will have to absorb this loss of income by making savings whilst continuing to encourage people to recycle more
Highway verges	Spelthorne has been managing highway grass cutting on behalf of Surrey. For 2018/19 Surrey reduced the amount it pays Spelthorne for the service by 36% or £47,000	Spelthorne has had to offset this loss of income by making changes to grounds maintenance arrangements

At Spelthorne Council we are closely monitoring the situation and doing all we can to minimise the impact on our residents but the scale of the cost savings which Surrey need to achieve mean it will not be possible for Spelthorne to step-in in every single instance.

## **Spelthorne calls for Heathrow compensation for residents**

Heathrow's recent consultation showed just how much the planned expansion is likely to affect people's day to day lives. Although the Council has been a long-standing supporter of Heathrow expansion due to the economic benefits, it is imperative that residents are properly compensated.

The Council is particularly concerned that, under the current proposals, Spelthorne residents will not benefit from the package of measures known as the "Wider Property Offer Zone." These measures include residents being able to sell their home at the market value of the property "as if expansion had never been promised or taken place" plus a 25% uplift. Excluding south of the airport from the WPOZ suggests that Heathrow has come to the conclusion that Spelthorne communities will not be newly impacted by expansion. That assumption is simply wrong.

We believe that communities will be newly impacted by:

- airport development brought far closer to homes, families and schools
- construction, bringing enormous disruption to the local area
- more flights, both before and after expansion, with associated noise and air quality challenges
- more traffic coming on to local roads due to planned reconfiguration of routes
- more airline passengers parking in local roads to avoid airport parking costs
- more taxi and private hire vehicles waiting in residential roads with associated littering and annoyance to local residents
- loss of valued open space
- ecological impact on Staines Moor
- loss of community spirit
- affect on property prices and being able to sell their homes

Cllr Ian Harvey, Leader of Spelthorne Borough Council, said: "Whilst we recognise the economic benefits that expansion can bring to the local area as well as nationally, it is important that we continue to fight for our residents to be properly compensated and left with community legacy benefits. We must not be the poor relation in terms of the compensation packages on offer elsewhere."

Leaflets were sent to residents in Stanwell and Stanwell Moor in May to raise awareness of the likely impact of Heathrow expansion and what the Council is asking Heathrow to do to address it.

## **Spelthorne backs Southern Light Rail to Heathrow**

Spelthorne Borough Council welcomes the fact that the Government is actively looking at rail access to Heathrow, and recognises that this needs to be addressed. We also welcome the fact that the announcement says the Government is looking at innovative solutions. As a major beneficiary, we would expect Heathrow Airport Limited to contribute financially to any final scheme.

We are promoting a proposal to introduce a Southern Light Rail scheme (SLR) to open up access to Heathrow from the entire south western railway network. This would also improve access to the airport for Spelthorne residents, including those who work at the airport, and bring economic opportunities to Staines town centre.

Light rail solutions for airport surface access have been tried and tested across the globe with similar schemes in locations such as Dubai, Bangkok, Beijing and Vancouver. This technology is widely recognised as a reliable, resilient and convenient transport solution. This system could be constructed quickly and in time to align with, or ahead of, the airport expansion timetable.

A light rail proposal could offer a frequent service from the existing station at Staines-upon-Thames with prospective intermediate stops for airport park-and-ride facilities.

The construction cost would be much lower than a heavy rail scheme and therefore deliver a cost effective solution to meet Heathrow's aim to improve access to the airport through greater use of public transport. The Government is currently looking at the options and is expected to report back in the autumn. More details will appear on our website and in the Bulletin as the scheme develops.

Purchasing a brand new fleet of vehicles demonstrates the Council's commitment to provide quality services for its residents.

## **Plans for a new leisure centre announced**

Spelthorne Council has announced plans to build a new leisure centre in the Knowle Green area of Staines-upon-Thames.

Spelthorne Leisure Centre, the Council's current facility in Staines, has served the community well since it was initially opened as a swimming pool in the 1960s before being extended in the late 1980s to become a leisure centre. However, customers' leisure requirements have changed over time and surveys have indicated that a considerable investment would be needed to extend the life of the centre beyond 2021.

The Council is proposing to build a new 'flagship' leisure facility which will offer a fresh modern design and meet the high expectations of residents well into the future. The old centre will remain open while the new one is being built to ensure continuity of service. A section of Staines Park which is owned by the Council and currently occupied by tennis courts and a bowling club has been identified as a strong contender for the location of the new leisure centre.

Sunbury Leisure Centre is not affected by the changes.

Thank you to everyone who came along to the public consultation events in June. The feedback received has been invaluable in helping us to gauge what facilities residents would like to see provided at the new leisure centre. Our online consultation closes on Monday 23 July so there may still be time for you to give us your views if you haven't already. A second consultation is planned for September.

## **Houses in Multiple Occupation (HMOs) – the law is changing**

The law has changed to expand HMO licensing, meaning that from 1 October, houses in multiple occupation with five or more people, regardless of the number of storeys the building has, will need to be licensed. Currently only HMOs with three or more storeys and five or more people living there need to be licensed. The aim is to give tenants more protection and safer homes, and drive up standards in the private rented sector.

A house in multiple occupation is a property occupied by three or more people forming two or more households, and there is usually some sharing of basic amenities such as kitchens and bathrooms.

Further details of Spelthorne's HMO licensing scheme will be available in due course. ## **Spelthorne powers ahead with solar panels**

The Council has recently installed solar panels at the Community Centres in Ashford (Fordbridge) and Staines-upon-Thames.

The renewable energy generated by the solar panels will be used to run the centres, reducing the energy required from the grid and contributing to the Council's ongoing work to reduce its own carbon emissions.

As well as providing a cheaper source of energy, the power generated provides an income through the Government's Feed-in Tariff, representing a net profit of £90,000 over the 25 year lifespan of the panels.

## **Spelthorne Takes Shape**

The Council is currently working on a new Local Plan which will detail how much development is needed in the Borough over the next 15 years and where it should go. The finished Local Plan will contain policies for deciding planning applications and allocating sites for housing, commercial units and other forms of development.

During May and June, the Council consulted on the first stage of the new Local Plan, known as Issues and Options. The consultation paper set out the key issues affecting Spelthorne to 2035 and outlined the four strategic options the Council will consider in order to meet the Borough's needs. As well as identifying the challenges and constraints, it also looked at the opportunities for growth in Spelthorne.

Thanks to everyone who came along to the information events and responded to the consultation. Our staff spoke to lots of residents and gained a good understanding of the local issues that are important to our communities. The Council will now be developing 'preferred options' for the new Local Plan, using feedback from the consultation, before holding two more consultation stages. The plan will then be submitted to the Secretary of State who will confirm if it can be recommended for adoption.

## **Make sure you are registered to vote**

The annual voter registration form will be delivered to every household in Spelthorne at the end of July/beginning of August 2018 in preparation for the publication of the register on 1 December 2018.

You can return the form by post or register by phone or online if your household details haven't changed. This facility is quick and easy and will save the Council money. Full details of how to use these services will be included in the envelope alongside your registration form.

When the Electoral Register is published it will be used for the Local Council Elections scheduled for 2 May 2019 and any other elections or referenda that may take place prior to 30 November 2019.

The Electoral Register also proves where you live and credit agencies use it to help make decisions on applications for mortgages, bank accounts, loans, mobile phone contracts and other credit facilities.

## **Top tips for boarding your pet**

- Make sure the kennel or cattery is licensed with the Borough Council in which it is located. Licensed premises must meet certain standards and it is illegal to run a "boarding establishment" without one
- Are your dog's vaccinations up-to-date? It will need vaccinations against canine distemper, canine adenovirus, leptospirosis and canine parvovirus. You will need to show a copy of your vaccination certificates (your vet can reprint these if required)
- All licensed catteries must insist on seeing an up-to-date vaccination card, showing recent (within the last 12 months) vaccinations against cat flu and enteritis
